Whenever possible, families are involved in treatment planning, regular family therapy and visitation while a resident is participating in the program. Staff members also work with families to develop aftercare plans and to secure community resources prior to reunification.

Special Interventions Available Internally

Boys and Girls Haven offers therapeutic interventions to meet the individual needs of our residents. These interventions include substance abuse services, equine-assisted therapy, expressive therapies, JSO counseling and trauma-informed care. We also offer an on-campus school, athletic and recreational activities, art activities and horticulture program. All residents participate in IL skills training, and older youth have access to vocational training and job placement services.
