Our program is licensed to serve the populations of foster care, therapeutic foster care, foster to adopt, and have homes for parenting teens, Hispanic, sibling groups, clients working toward independence, and we are expanding services every day to better meet client needs. Our program trains the entire treatment team in the Positive Discipline evidence based practice model we use and specializes in the individualized treatment approach that every client deserves. Our success is seen in the credentials and experience of our staff as detailed below, the longevity of our foster parents, and the number of clients who have found forever homes (currently over 350 clients have been adopted in the last three years) through our foster-to-adopt emphasis across the Commonwealth.
